Responsibilities:

- Provide clinical supervision to 6-10 Associate Clinicians, trainees, and interns, to support their development and progress towards licensure.

- Oversee clinical documentation and ensure accuracy, completeness, and compliance with Medi-Cal, BBS, and agency standards.
- Monitor supervisee's caseloads to ensure ethical, effective, and high-quality service delivery.

- Train and support clinical staff in best practices, service models, and compliance requirements at the state and federal levels.

- Master's degree in Social Work, Marriage and Family Therapy, Counseling, or a related field and current California Licensure (LCSW, LMFT, or LPCC) required.

- Minimum of two (2) years of clinical supervision or directly related experience supervising clinical staff.
- Strong understanding of Board of Behavioral Services (BBS) ethical standards and Medi-Cal regulations.
- Working knowledge of Medi-Cal documentation and related regulations, with the ability to train for and monitor compliance.
- Ability to proficiently interpret clinical reports preparing written materials and present information effectively in varied situations.
- Skilled in mentoring, leadership and staff development.
